TO RECEIVE MR. C. STUCKI, BUSINESS DEVELOPMENT MANAGER FOR H2ENERGY; MR. K. REES, MANAGER FOR PUMA ENERGY; AND MR. J. RUGHANI, HYDROGEN BUINESS DEVELOPER, TRAFIGURA GROUP – REGARDING THE DEVELOPMENT OF AN ELECTROLYTIC HYDROGEN PROJECT AT PUMA ENERGY'S PREMISES IN MILFORD HAVEN.

The Mayor, Councillor Miss K. F. Gray, welcomed Mr. Stucki, Mr. Rees and Mr. Rhugani to the Meeting.

Mr. Rhugani explained the strategy behind the joint project. There will be excellent infrastructure in place with re-purposing of skills for a landmark project. Mr. Rees explained Puma Energy who have a lower incident rate at the present time than ever before. They have an excellent COMAH site. Mr Stucki explained H2Energy – a green energy company with renewable sources from off shore wind. The largest site in development is in Denmark. The goal is to help the UK become energy independent with the supply of carbon-neutral heat to more than 40,000 households. The plant could supply clean hydrogen from South Wales to industrial clusters in Milford Haven, Port Talbot and other areas.

Planning for the project is scheduled to start early in 2023 with work planned for later in 2023 with the plant working by 2025. Due to Milford Haven's long history of oil, gas and renewable energy it is a key location for building a new energy infrastructure to meet the decarbonisation goals of both Wales and the UK as a whole. The region is an obvious place to locate a hydrogen plant.

Questions were invited from Councillors. Brochures were given out at the meeting.

The Mayor thanked the gentlemen for attending. Mr. Stucki and Mr. Rhugani stayed to listen to the presentation by Milford Haven Port Authority.

TO RECEIVE A PRESENTATION FROM MR. T. SAWYER, CHIEF EXECUTIVE, PORT OF MILFORD HAVEN, WITH AN UPDATE ON THE WORK OF THE PORT OF MILFORD HAVEN

The Deputy Mayor, Councillor Mrs C. Stevens, joined the Meeting during this presentation.

The Mayor welcomed Mr. Sawyer; Mr. S. Edwards, Commercial Director, Port of Milford Haven; and Ms A. Malloy, PR & Communications Manager, Port of Milford Haven, to the meeting.

Mr. Sawyer explained the Freeport Bid. It is a collaboration between Milford Haven and Neath Port Talbot. The goal is to decarbonise Milford Haven and Port Talbot, if this cannot be done then Wales cannot be decarbonised. The project would make a major contribution of Wales' net zero carbon emissions and enhance security of supply. 16,000 new jobs could be provided.

Currently Pembrokeshire has a poverty rate of around 34%; the Freeport could bring in ± 5.5 billion in new investment. Milford Haven Port Authority have been on the Freeport journey for twelve months. The Freeport policy is to deliver innovation, investment and net zero emissions. There are 8 port areas within the UK.

Mr. S. Edwards greeted the Councillors stating how nice it was to be able to present in person.

In Wales 600 hectares have been identified; 335 in Neath Port Talbot with 265 in Pembrokeshire. Both Carmarthenshire and Swansea agree with the collaboration between the Port Authority and Neath Port Talbot.

The Freeport will make tax zones to encourage investors. The plan is to have 266 turbines floating offshore by 2035. This energy policy is shared by both the Welsh Government and the UK Government. Welsh Government and the UK Government are the decision makers for the Celtic Freeport Bid. Ministers Crabb and Kinnock are both on board with the plans.

Business rates will be reinvested within a Freeport project. Local manufacturing would be used and manufacturing would be encouraged to return to Pembrokeshire.

Mr. Sawyer then gave an update of the Port Authority plans.

There will be no dilution of activity around the waterway. An increase in water traffic will have to be accommodated. None of the Freeport encroaches onto the National Park, it is all outside of that area.

There are ambitious plans for Pembrokeshire with a National Gallery for Wales in the plans. Heritage, culture, education – Milford Haven Port Authority are interested in developing all of them. There is also a five-year plan for the marina. There is currently a waiting list for over 200 berths; the Marina will have to be expanded. There are also investments to be made in Pembroke Dock.

The Mayor thanked Mr. Sawyer, Mr. Edwards and Ms Malloy for attending.
