FEES, PAYMENTS AND SUMS FIXED BY THE MILFORD HAVEN TOWN COUNCIL, UNDER SECTION 214 AND PARAGRAPHS 12 AND 13 OF SCHEDULE 26 OF THE LOCAL GOVERNMENT ACT, 1972 AND APPLY TO ALL BURIALS IN, AND OTHER MATTERS ASSOCIATED WITH THE MILFORD HAVEN CEMETERY, MAINTAINED AND PROVIDED BY THE MILFORD HAVEN TOWN COUNCIL.

The fees, payments and sums set out below apply where the person to be interred or in respect of whom the right is granted is, or immediately before his/her death was, an inhabitant of the District of Milford Haven, or in the case of a stillborn child, where the parents (or one of them) are, or at the time of interment were, such inhabitants. In all other cases, the fees, payments and sums will be increased by 50% (if resident of Wales) or doubled (if resident outside of Wales).

INTERMENTS

Includes digging of the grave, and apply only where the interment is made on a working day* or on the certificate of a coroner or registered medical practitioner that immediate interment is necessary. In all other cases, an additional 50% is payable.

NOTE

* Working day means Monday to Friday and excludes Statutory and Extra-Statutory holidays, 10:00 am to 3:00 pm (1st April to 30th September) and 10:00 am to 2:30 pm (1st October to 31st March).

EXCLUSIVE RIGHT OF BURIAL

| (d) | For the right to construct, and for exclusive right of burial in a walled grave or vault | £902.00 |

An application to transfer burial rights shall be submitted, in writing, to the Milford Haven Town Council for its consideration.

CHARGES FOR INTERMENT OF CREMATED REMAINS

| (e) | Re-opening of graves in cremated remains Sections | £300.00 |

HEADSTONES etc.

For the right to erect a headstone or memorial on a purchased grave, including first inscription	£269.50
Second and further inscriptions	£128.70

*There will be a charge levied against monumental masons if it is found necessary to clear up
after a burial, or if it is necessary to re-align a headstone.*

Cremated remains tablets	£128.70
Second and further inscriptions	£ 60.00

Memorial pots <i>(when placed instead of a headstone)</i>	£128.70
Second and further inscriptions	£ 60.00

RE-MOUNDING OF A GRAVE

EXHUMATION

Exhumation of a single coffin	£990.00
<i>Plus any extra costs involved e.g. supplying of quick lime and spirits and removal of headstones and monuments, to be charged at actual costs.</i>	

CHAPEL

For placing a coffin in the Chapel during the night prior to interment plus use of Chapel for Service.	No Charge
